### A Bill to Amend the Constitution to Redefine the Student Health Board

## **Bill History**

In the course of evaluating the structure of the Wardenburg Health Center, it was determined that the current governance of Wardenburg should be amended to create a University advisory board to be known as the Student Health Advisory Commission to provide the oversight of the operations and budget of the Wardenburg Health Center, student health fees, and the student health insurance programs that the CUSG has historically performed. The Commission will be made up of an equal number of student and University administration representatives. No later than July 1, 2012 the University and CUSG will enter into a memorandum of understanding to establish the Commission.

This bill provides for a student vote to amend the Constitution to transition the existing Student Health Board, a joint board, to an advisory board to continue to provide student input on student health and wellness issues, including, but not limited to, operations of the Wardenburg Health Center, student health fees, and student health insurance programs.

# **Bill Summary**

This bill seeks to amend the University of Colorado Constitution to address issues pertaining to the oversight of Wardenburg Health Center.

THEREFORE, BE IT ENACTED by Legislative Council of the University of Colorado Student Government, THAT:

**Section 1:** As an amendment to the Constitution, the following question shall appear on the Spring 2012 ballot as a referenda question to the student body. "Shall the University of Colorado Student Government Constitution be changed to:

#### Remove:

- "Article VII Section I. The Student Health Board
  - 1. The Student Health Board shall include eight students.
    - a. Two to be chosen by the Executive from the Representative Council one each semester. The Legislative Council must approve the choice.
    - b. Three to be appointed by the Legislative Council.
    - c. Three to be appointed by the Student health Board with Legislative Council ratification.
  - 2. The Student Health board may include, one non-student, making the total voting membership of the Board nine. A member of the medical community, not connected with Wardenburg should fill this position."

### Addition of:

"Article XVIII Advisory Boards

- A. Student Health Advisory Board
  - 1. The Student Health Advisory Board shall include nine student voting members, appointed by the Student Health Advisory Board.
  - 2. The Student Health Advisory Board must include these three ex-officio members:
    - a. A CUSG Executive or appointee
    - b. A Legislative Council member appointed by the Legislative Council President
    - c. The CUSG executive staff member charged with student health matters.
  - 3. The Student Health Advisory Board shall regularly provide information related to Wardenburg Health Center, student health fees, and student health and wellness."

**Section 2:** This bill takes effect upon final passage by Legislative Council and upon either obtaining the signatures of the CUSG Legislative Council President and Executives or the lapse of six days without action by the Executives.
