Bill Summary

The attached spreadsheet is the official document containing all approved allocations for the 2013-2014 FY Student Fee Package. Adjustments may be made to account for changes in the combined GAR/GIR rate, police recharge and the allocation to CU Colleges and Schools.

THEREFORE, BE IT ENACTED
